Key Cases

- Successfully argued before the New Hampshire Supreme Court on behalf of a group of commercial tenants against their landlord who had breached their lease agreements.
- Successfully defended former owner/high-level executive of a for-profit hospital group against a \$2.4 million dollar contribution claim, limiting liability award to ten percent, later substantially reduced in settlement.
- Part of patent litigation team representing a leader of fully automated, high-precision, high-speed die bonding and epoxy dispensing systems that successfully won the country's first-ever bench trial held on the issue of IPR estoppel and after five years of litigation, successfully defended a \$40 million dollar claim by obtaining summary judgment based on patent invalidity.
- Successfully argued before the District of New Hampshire with the American Civil Liberties Union on behalf of a noncriminal noncitizen to obtain habeas relief after her due process rights had been violated when she was detained in ICE's custody for over 10 months.
